- Introduction by Sandy Stevens. Houston Police Department South Central Station's Lieutenant Robert Hernandez and Commander Caroleta Johnson
 - Crime stats from Dec 2021 compared to Dec 2020, overall Museum Park (includes Med Center and a part of Midtown that includes the Greyhound Bus Station) is low compared to CoH.
 - Property crimes were an issue at the beginning of last year. Patrols were increased resulting in a decrease.
 - MPNA's beat Zero murders, 36 robberies (primarily near Greyhound Bus terminal), 107 aggravated assaults
 - Suggestions to coordinate assimilation services at the bus station to help avoid recidivism. CM
 Shabazz will reach out.
- Introduction by Sandy Stevens. District D Council Member, Carolyn Evans-Shabazz. 2022 District D Goals and issues
 - Traffic / Pedestrian safety. Crawford and La Branch as they cross Binz as well as other areas are dangerous and are being studied
 - Almeda parking/ noise. Training of officers on sound meters is one part. Working on an Ordinance that includes entertainment and construction noise.
 - Development. No zoning, so options are to manage through compliance with ordinances and permitting.
 - Homeless solutions. Area across from Greentown Labs is a recent congregating issue. HPD coordinating to re-secure the gate to area and for cleanup.
